# **MINUTES of the Annual Business Meeting**

Thursday, August 18, 2005

# A. Overview of the Meeting

Dr. Leventhal welcomed the membership, introduced the Board members present and discussed the planned agenda. The agenda included reviewing the activities of the Board over the last year and a number of topics for discussion including the upcoming national conference, the AMSP-JCPMS relationship, a potential name change for the organization, the role of student members, and initiatives for the coming year. Members were also provided with general information about the organization (AMSP brochure, AMSP program events at APA, AMSP consultation program, information about JCPMS, and information about the AMSP website) and a copy of the AMSP semi annual Treasurer's Report.

It was noted that there is another symposia offered through Division 12 listed as a Section offering and AMSP members were also encouraged to attend this event.

#### C. JCPMS

Drs. King, Leventhal and Rozensky discussed meeting with representatives from Springer at the APA convention to finalize the relationship between JCPMS and AMSP. The membership was informed that in 2006 access to JCPMS will be electronic. Drs. Leventhal and Hong also spoke to the membership about the goal of adding a special feature to JCPMS which would provide articles with an educational description of a specific illness with an associated case. The case and educational information would then be followed by a discussion from 3-4 senior clinicians who would comment about the case. The title would be "A case presentation of a topic from the AMSP."

### D. Name Change for AMSP

Dr. Leventhal explained to the membership the rationale for why the Board had proposed a name change from AMSP to the Association of Psychologists in Academic Health Centers. He also indicated that the impression of the Board remains that most members support a name change. He urged members to vote if they had not done so.

# E. National Conference Planning

Dr. Seime explained that the Board is planning for an AMSP national conference set for September 7-9, 2006 in the Washington DC area. He solicited ideas for membership about funding sources and topics. Members suggested that the topics be varied to provide program material for all level of participants (i.e. students, interns, fellows, new faculty, senior faculty), include consultation sessions on topics like publishing, grant writing, negotiating salaries, developing interdisciplinary collaborations, and possibly be tracked by themes. There was discussion of whether the recent IOM report on enhancing the behavioral and social sciences in medical school curriculums could be a focal point for some of the presentations.

Due to time constraints other items on the agenda could not be discussed. The next Business Meeting of AMSP will be held during the 2006 American Psychological Association Convention (time and location to be announced).
