- 1. Call to order: Meeting called to order at 5:04 pm EST. June Meeting minutes approved by the Board.
- 2. President's Report and Items for Discussion (Dr. Cathy Schuman):
 - a. (appointed) AAMC Council of Faculty and Academic Societies (CFAS) Representatives (Jan 1, 2015 Dec 31, 2017) AAMC CFAS had a deadline to nominate second CFAS rep by the end of the month. To meet the deadline, Dr. Schuman appointed William N. Robiner, PhD, ABPP without a vote from the Board.
 - b. Clinical Health Psychology Specialty Council-Council within APA's Synarchy, which has been a slow building workforce and may increase with time. Currently reviewing postdoctoral training curriculum. Dr. Schuman will transfer APAHC's involvement to the next APAHC President, Dr. Butt.
- 3. Treasurer's Report (Dr. Amit Shahane): New credit card received for APAHC. Dr. Shahane suggested using free conference call option to save on costs. While our fee for our current conference call structure is low, we may want to consider a free structure. Board members listed suggestions for free conference call options.

 - 1. Journal/JCPMS (Dr. Jerry Leventhal): Working with Dr. Cash to complete 2017 APAHC Conference-related special journal issue. Identifying reviewers with student and diversity committees.
 - Newsletter (Dr. Cesar Gonzalez): Dr. Schuman will speak with Dr. Gonzalez and have a response for the Board regarding his involvement by August Board Meeting.
 - 3. Website (Dr. Isakson unavailable for call): Dr. Shahane reported Drs. Isakson, Ward and himself have spoken about the website. Identified having link for APAHC website from D12 website. Another call is scheduled within the month and will provide update for Board in August.
- e. CFAS (Dr. Laura Shaffer): No updates.
- f. Division 12 (Dr. Donna LaPaglia unable to attend call; yet, sent information via email): Dr. LaPaglia will connect with Tara Craighead (D12 Director of Operations) at the APA Convention in DC about their website and any other issues APAHC may need clarification on.

Manuscript is based on data from the team-based care section of the recent APA membership survey. Dr. Washburn has taken the lead on completing the final edits of the manuscript. Lastly, the Research Committee has also been discussing the APAHC membership survey with Dr. Ward.
- h. Diversity Committee (Drs. Roseanne Illes and Michael Mejia): Networking at APA Conference to increase APA collaborations with other APA Divisions. Dr. Shaffer suggested D54 for potential collaboration. Diversity Committee members will have opportunity to serve as reviewers for JCPMS with Diversity special section.
- i. Student Representative (Teresa Y. Pan, MA): Students may be involved with reviewing process for JCPMS.
- j. Early Career Representative (Dr. Leila Islam): Identifying takeaways from past APAHC conference to assist with planning for future Early Career Boot Camp.
- 5. New Business:
 - a. Funding for APA Speaker: Dr. Butt reported that Dr. Riley was not anticipating attending APA Convention. Board approved to pay for his registration for the Convention. Dr. Butt is working with APA to determine if Dr. Riley can have his registration fee waived.
